SECTION A – Project Overview

Project: "Mantracker" Reality TV Series

Purpose: To digitally tape TV episodes where two (2) hosts/'mantrackers' on horseback pursue two contestants who are running away (prey) on foot.

The chase will be documented by three camera persons on foot with hand-held digital cameras.

Location: It is anticipated that 2 episodes will be taped June 20 – June 30, 2011 in Barriere area and 2 episodes will be taped along Cahilty Recreation Horseback Riding trails & area in spring, summer or fall of 2012.

2011 - On and along the Seven Sisters and other recreational horseback riding trails and surrounding areas (Barriere, BC) as identified and marketed for tourism in North Thompson Trail Guide. Also, prey will paddle a canoe from shoreline of North Thompson to McLure Ferry. GPS coordinates supplied for Barriere area.

2012 – Cahilty Trail around as identified and marketed for tourism in North Thompson Trail Guide - Tod Mountain Recreational Horseback Riding trails. Map supplied.

Access will be along established recreational horseback riding trails and old forestry roads.

No construction. No heavy equipment.

SECTION B – ACTIVITY INFORMATION

Film Activity: Preproduction involves driving and hiking along the trails to investigate area. An ATV may be utilized with two persons in area for one day.

Production: June 20 – June 30, 2011 with June 25 off.

Post-production Clean-up: None required but will survey area and clean as traveling. Before and after photos may be supplied as required.

Cast & Crew: 10 at most altogether
-2 Prey (contestants) on foot
-3 Camera men on foot
-2 Hosts on horseback

- 1 Director in small SUV or ATV
- 1 Location PA riding with the director
- 1 Logistics liaison (Connie Falk, Tiara Sans Consulting)

- Accommodation:** While filming, water, food & home base will be in SUV on trail or forestry road, or at closest recreation site - as close as possible to taping. Any camping will take place at recreation sites. Normal usage as zoned - like tourists for recreation. Evenings cast & crew may retire to Barriere, BC. On June 21 and June 27th the prey will be camping at a normal recreation site)
- Access:** Vehicles & horses access area by established old forestry roads and/or recreational horse riding trails
-2 horses for mantrackers
-1 small SUV (director, production assistant, food, water & equipment)
-1 ATV (if required)
- First Aid:** On-site First Aid Attendant; closest clinic is in Barriere;
Closest hospital is Royal Inland Hospital in Kamloops.
- Sanitation & Refuse Disposal:** Minimal garbage so carry-with and pack-out. Use recreation site's facilities.
- Stunt & Special Effects:** None.
- Vegetation, Soil & Water:** Minimal disturbance and impact.
2 contestants on foot and 2 horses pass through brush with 3 camera persons on foot along cow trails, established trails and at one point at shoreline of North Thompson River. Pass once – no repetitive impacts.

SECTION C – ADDITIONAL INFORMATION

1. Environmental

- 1a. Land Impacts:** Minimal if any. Nothing disturbed except land & vegetation from hiking and horses walking through.
- 1b. Atmospheric Impacts:** None. No vehicle idling. No generators.
