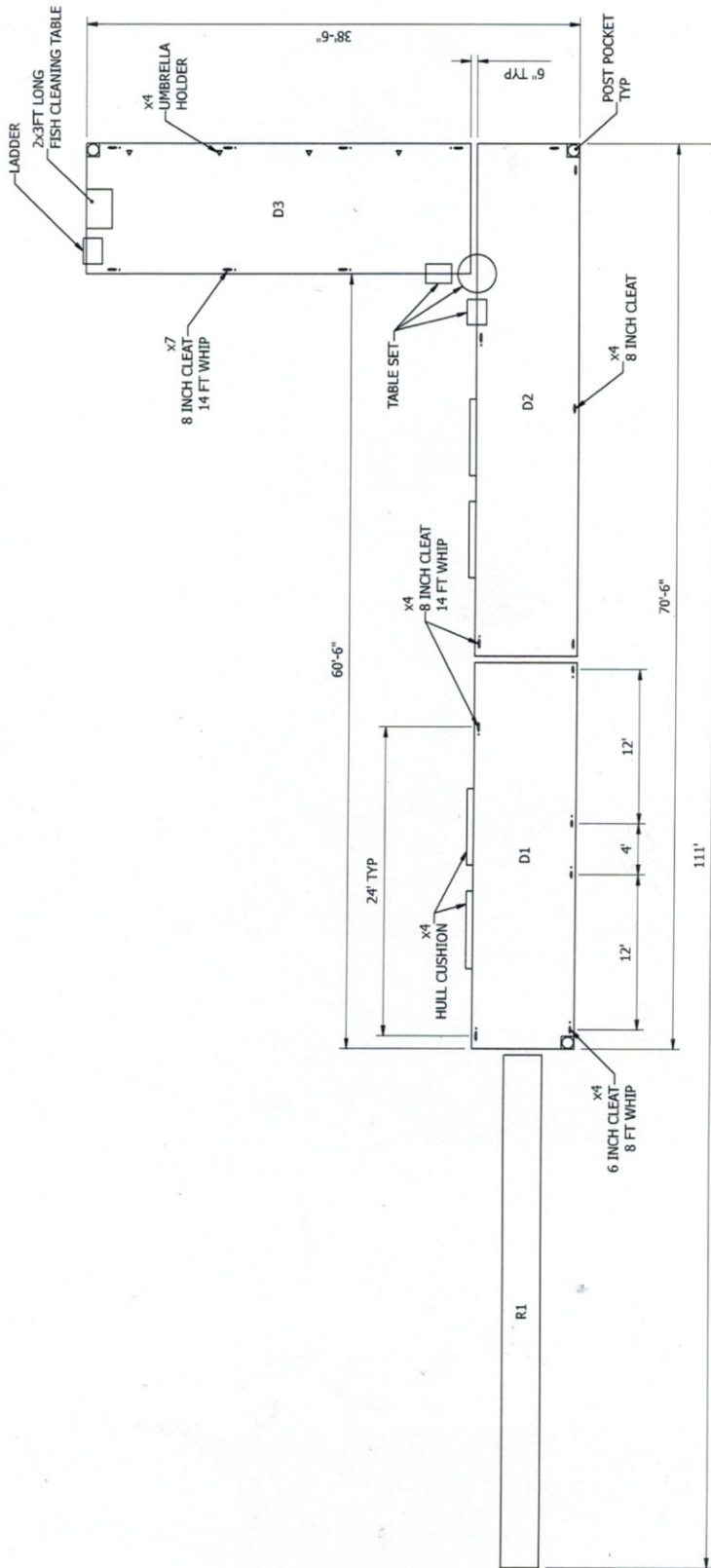

Background:
